OF THE CITY OF SANTA ROSA  
AMENDING CHAPTER 15  
(SEWERS) OF THE  
SANTA ROSA CITY CODE**

The proposed ordinance reduces sewer demand fees based on a revised methodology and updated demand analysis; revises Table 15-1 with updated monthly wastewater flow estimates for Commercial, Industrial and Institutional users; and adds language allowing sewer demand fees to be paid according to language in Chapter 21 of the City Code consistent with all other development impact fees.
