NOTICE IS GIVEN that the Sonoma County Board of Supervisors intends to authorize the Director of the Department of General Services, or his Deputy, to execute an Assignment and Amendment of a Commercial Lease ("Assignment") with B. I., Incorporated ("BI"), for County acceptance of the rights and obligations under the existing lease between BI (tenant) and Southport Land and Commercial Company (landlord) for approximately 5,840 sf of office space at 2400 County Center Drive, Suite A, Santa Rosa ("Premises"), with a monthly rent of \$6,815.28 plus the cost of utilities and common area maintenance estimated at \$1,100 per month.
