ORDINANCE 6087

SUMMARY OF ORDINANCE 6087 OF THE SONOMA COUNTY BOARD OF SUPERVISORS REGARDING DELEGATION OF AUTHORITY FOR LEASING OR LICENSING REAL PROPERTY OWNED BY THE COUNTY

On October 21, at 2:00p.m. in the Board of Supervisors Chambers at 575 Administration Dr., Santa Rosa, California 95403, the Board of Supervisors considered for adoption, and on October 28th, 2014, the Board adopted, an ordinance amending Article XVII of Chapter 2 of the Sonoma County Code to revive delegated authority to the General Services Director to enter into agreements for low value leases and licenses; increase the rental amount subject to delegation from \$2,000 to \$10,000 per month; increase the term subject to delegation from five years to ten years; waive bidding requirements for leases and licenses subject to delegated authority; expand these delegated authorities to the Directors of Regional Parks and Transportation and Public Works, and the Airport Manager for properties they manage; authorize the county officers to convey certain property interests to other government agencies for a period of up to a year; and clarify that the Board retains its authority regarding conveyance of real property interests pursuant to applicable law, including but not limited to Government Code Section 25536.

SONOMA COUNTY HISTORY

In 1962-1963

Sonoma County Historical Society organized with 8 members.

The "Hippie" revolution was centered in west Sonoma County. Musician Lou Gottlieb opened the Morningstar Ranch west of Sebastopol; others flocked to Wheeler Ranch and turned summer cabins into year-around residences.

Forestville built its first park.

The incorporation of Waldo Rohnert Seed Farm into Rohnert Park, the brainchild of developer Paul Golis, took place. By 2000, the population reached 40,000.

Civil rights became a public issue with a sit-in at Silver Dollar Saloon on May 20th.

Phyllis Cantrell of Santa Rosa flew in four Powder Puff Derbies in the 1960s.

Cotati's new, expanded hillside St. Joseph's Catholic Church looked out on Hwy. 101.

Cotati was incorporated on July 2, 1963.
