**SONOMA COUNTY HISTORY**

**In the 1946**

Petaluma Leghorns semi-pro football team played their first game against USF Frosh on Armistice Day. The team continued with full seasons through 1958.

Benny Friedman opened a hardware store in Petaluma, moving to a large facility in Santa Rosa in 1970; Friedman was the major contributor to the saving of the Christian Life Center building and built the Friedman Center for the Jewish community in 1990.

The Santa Rosa City Council worked on traffic, sewer, and water issues; the council labeled Santa Rosa "The City Designed for Living."

The Army air base north of Santa Rosa was to become the Sonoma County Airport.

Until 1972, Guerneville Stumptown Daze hailed the arrival of tourist season.

With a long history of major fires, Occidental organized its volunteer fire department.
