SONOMA COUNTY HISTORY**In 1886**

A.P. (Boss) Overton, formerly a Petaluma constable, county district attorney and judge, became Santa Rosa's mayor. Santa Rosa constructed its sewer system.

Frances McCaughey Martin became the first female school superintendent in the county; Minnie Coulter was the second in 1898.

Santa Rosa bought a powerful steam engine for fire volunteers.

Healdsburg's first city hall was built for \$12,500; It was demolished in 1960. Healdsburg public high school opened, graduating eight girls and one boy in 1891.

John Hallberg and his son Oscar used innovative techniques to build an apple-growing empire in west Sonoma County.
