SUMMARY OF AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HEALDSBURG ADOPTING THE CITY OF HEALDSBURG 2015-2023 HOUSING ELEMENT (GENERAL PLAN AMENDMENT 2014-03)

NOTICE IS HEREBY GIVEN that on December 1, 2014, the City Council of the City of Healdsburg adopted Ordinance No. 1143 upon second reading, reading title of and waiving further reading of the text, by the following vote:

The Ordinance approves General Plan Amendment 2014-03 to approve the City of Healdsburg 2015-2023 Housing Element. The ordinance replaces the text of current General Plan Chapter 3 - Housing in its entirety with the text of Chapter 8 - Housing Plan of the City of Healdsburg 2015-2023 Housing Element, which updates the current Housing Element and, among other things, specifically furthers promotion of a mix of housing types and affordable housing distributed throughout the community and maintenance of a jobs/housing balance.
