## In 1892

Thomas Lake Harris left Fountaingrove and was succeeded by Japanese Wine Baron Kanaye Nagasawa, who ran the operation until his death in 1934.

Petaluma and Santa Rosa High Schools played a series of football games.

Carlson-Currer established the only silk mill in the western U.S.; the business survived more than 100 years.

Penngrove's first post office was opened in the Ronsheimer building.

Thomas Barlow Ranch near Sebastopol was the leader in the planting of numerous berries, including blackberries.

**SONOMA COUNTY HISTORY**

## In 1927

The Giacondo Benedetti family moved from Italy to Sonoma, Santa Rosa and Cotati. Son Gene became a major figure in sports and in the dairy business after World War II.

Promoter Charles Pyle organized a 480-mile "Indian Marathon" running event from San Francisco to Grants Pass, Oregon on Hwy. 101 in 1927-28. Mad Bull, aka John Southard, won the 1927 race in 7 days, 12 hours, 34 minutes; Flying Cloud won in 1928, covering the distance in 7 days and winning by 17 miles.

Auto dealers held a 120 mile Sonoma County run in a White Ford. Three drivers logged 2,813 miles, averaged 43.5 miles per gallon at a speed of 25 mph.

24,000 vehicles operated in Sonoma County, including 19,000 autos.

Cotati organized its volunteer fire department.

P&SR railway opened a mission-style depot at 4th and Wilson Streets in Santa Rosa.

Six women, including poet Eugenia T. Finn and Nell Griffith Wilson, formed the Sonoma County branch of American Pen Women.
