SONOMA COUNTY HISTORY

In the 1928

The Gravenstein apple boom saw 1,800 carloads of fruit go to eastern and southern markets.

Star running back Ernie Nevers helped the semipro Santa Rosa Bonecrushers football team win three straight state titles (1928-30).

John Greeott bought a large ranch on Chalk Hill Rd. Son George bought the ranch, growing grapes, and became a folk artist and invented a horseshoe known as the Greeott Grabber.

Conductor George Tromblev arrived and formed the Santa Rosa Symphony: the first concert was held in April at the Elks Club. He conducted for 30 years, building the group into a 60-piece professional orchestra.

Sonoma Mission Inn Golf and Country Club course opened, taking heavy losses during the Depression but survived when it was purchased by Alma Spreckels.

Penngrove organized its volunteer fire department.
