SONOMA COUNTY HISTORY

In 1926

Luther Burbank's comments on "life in the hereafter" drew international criticism; he died April 10th of a heart attack.

In perhaps the closest major race ever, Douglas Bills beat Petaluma Police Chief Mike Flohr by less than 20 votes in an election for sheriff. Flohr won a rematch in 1930.

McNear family gifts included land for McNear Park in Petaluma, a fire station and the Petaluma Golf Club.

Petaluma's population was 7,000; 2,000 chicken farms operated in or near the Egg city.

Al Hermann, noted for his ability to do a variety of chicken calls, built the Penngrove School.

Highway 101 reached Cloverdale.
